

Market Regulations Wollcraft Festival



Preamble:

Wollcraft Festival is a sales fair with the focus on wool, wool processing & handicrafts. The aim is the presentation of wool in all its variations for handicrafts, in particular spinning and felting fibers, knitting, crochet and weaving yarns, as well as matching accessories.

High quality goods are of great importance to us. This includes, among other things, hand-dyed or hand-finished, regional and sustainable products that are produced as animal-friendly and fair where possible.

The composition of the exhibitors should do justice to the aims of the event.

Event date:

Saturday 30.08.2025 and Sunday 31.08.2025

Saturday: 10.00 a.m to 5.00 p.m.

Sunday: 11.00 a.m. to 4.30 p.m.

Set-up & dismantling times:

Set-up: Exact times will be communicated at an appropriate time before the event.
Set-up will be possible on Fridays.

Dismantling: Sunday from 4.30 pm. The venue must be vacated by 8 pm.

It is strictly forbidden to pack before the event closes. In the interests of all participants, partial dismantling is also not permitted. In the event of violation, the respective exhibitor will be fined at least 200.00 € and the exhibitor will be excluded from all subsequent events.

Registration & admission:

Registration must be made in writing on the forms sent by the organizer. These must be completed in full and returned with a legally binding signature. By submitting the registration form, the applicant recognizes the conditions of participation, the valid prices and the technical guidelines in all points. The applicant is liable for ensuring that the persons working for them at the event also comply with these conditions.

Registrations are only valid after written confirmation by the organizer. There is no legal entitlement to admission. The organizer may refuse or revoke admission without giving reasons. The organizer is entitled to exclude individual goods before and during the exhibition.

Admission is only binding once the stand fee has been paid in full.

Terms and conditions of payment and cancellation:

The invoice is payable in advance by bank transfer within 10 days to the account stated on the invoice. In the event of non-compliance with the payment deadline, the space will be reallocated after a single reminder. If the owner of the venue withdraws from the contract, the organizer shall refund the registration fee, taking into account the precautions taken and expenses incurred.

The flat-rate reimbursement is staggered based on the date of receipt of the declaration of withdrawal by the participant as follows:

Up to 8 weeks before the event: 100%

Up to 4 weeks before the event: 50%

Within 4 weeks before the event: 0%

Liability:

The exhibitor is responsible for the security of their display and exhibits and is therefore liable for damage to exhibits, equipment and consequential damage. This also applies to set-up and dismantling times, before start and end of the event. Every exhibitor is advised of the increased duty of care. Displays may be left standing at night during 2-day events. After hours the following applies: After all exhibitors have left the hall together the rooms will be locked at night. However, the organizer assumes no liability for the exhibited goods. Damage caused by exhibitors or their suppliers must be reported to the organizer immediately. Witnesses must be called in if necessary and documented in writing and settled via the liability of the party responsible.

Display location:

Space is allocated by the organizer.

The organizer will not provide any display systems or partition walls. The display area will be marked and handed over in a usable condition. The marked display area may not be exceeded or altered. The exhibitor is obliged to return it in the condition in which they took it over, including the removal of garbage and display materials etc.

Display construction and equipment must be erected in a stable manner so that public safety and order as well as the life and health of persons are not endangered. Stabilization against neighbouring displays or the building structure is not permitted. The exhibitor is responsible for structural safety.

All exhibitors are obliged to make their stands visually appealing. In particular tables and stands - if they can be seen by visitors - must be covered at floor level. Backstock and goods not on display must be stored out of sight of visitors. Rented items as well as floors, hall walls and other fixed fixtures must not be damaged.

The general lighting of the event rooms are provided by the organizers. Additional lighting of the display is the responsibility of the exhibitors. Power supply (220V) can be booked upon registration.

Each exhibitor is responsible for the operational safety and compliance with occupational safety and accident prevention regulations at their displays.

Exhibitors are requested to register with the organizers BEFORE setting up their display. You will then receive exhibitor passes, which constitute your authorization to enter the hall. Two passes per stand are included.

Behavior on the event grounds:

Access to the event is only permitted on presentation of an admission pass or ticket. Admission for children and young people up to the age of 14 is only permitted if accompanied by an adult. Young people aged 14 and over have the same access as adults.

Dogs are not permitted on the entire event grounds. Assistance dogs with proof are exempt.

Smoking is prohibited in the event rooms.

Photo & video recordings:

The exhibitor is entitled to film and photograph during the event and to use the material for marketing purposes. This also applies to the press.

Rights of use of images and texts:

The exhibitor transfers to the organizer the rights to use the text and image material provided for marketing purposes.

Advertising and flyers:

The display of flyers and advertising material of the exhibitor's own brand at their display is permitted. The distribution of third-party advertising material is generally prohibited. Exceptions are only possible after prior agreement with the organizers.

Goods on offer:

Only the products named in the application may be exhibited and sold. The organizer must approve the sale of other goods. During the days of the event, checks will be made to ensure that the display matches the products mentioned in the application. The sale of any other products may be prohibited by the organizer. These products must then be removed from the display immediately.

Force majeure:

Serious events, such as force majeure, civil unrest, pandemic or other important reasons, entitle the organizer to shorten, postpone or cancel the event. The organizer also has these options in the event of significantly too little visitors. In the event of cancellation, there is no obligation to pay the exhibitor's stand fee. Any fee already paid will be refunded. A postponement of the event to an alternative date, on the other hand, shall initially have no effect on the contractual relationship between the organizer and the exhibitor.

However, the postponement shall give rise to a special right of termination for the exhibitor. The organizer and exhibitor are mutually obliged to notify each other promptly. Further claims against the organizer, esp. for damages are excluded.

Violations of market regulations:

The organizer has the domiciliary right. Anyone who violates the market regulations or otherwise behaves inappropriately may be excluded from the event by the organizer. In this case there is no refund of the fee. Likewise, in this case a claim for compensation against the organizers is excluded.

Severability clause:

Should individual provisions of this contract be invalid, this shall not affect the validity of the rest of the contract.

Place of jurisdiction:

The exclusive place of jurisdiction for all disputes arising from or in connection with the contract is the registered office of the organizers.
